

# 2026 Board of Directors Nominees' Statements

Our current honourary board members (Megan Dart and Ryan Eidick) were approved by the Board for a two-year term starting in 2025 and will continue to serve through 2026. Existing Executive Board Members (Chair, Vice Chair, Treasurer) are intended to serve a two-year term as well, as written in our Governance Guidelines.

## 1. Anastasia Arabia

(2025 Board Member)
